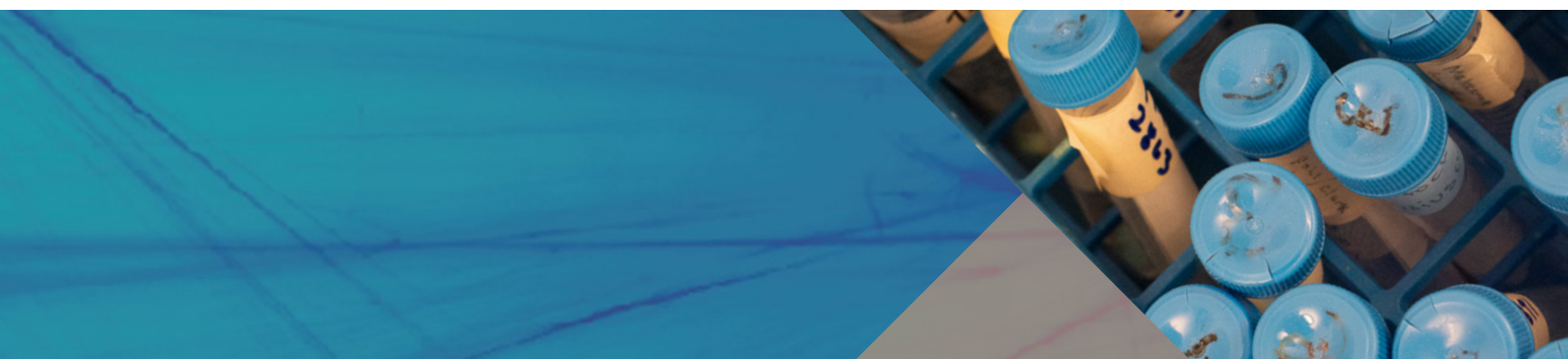
### Naming ARCS Seattle Chapter in your Will or Estate Plans

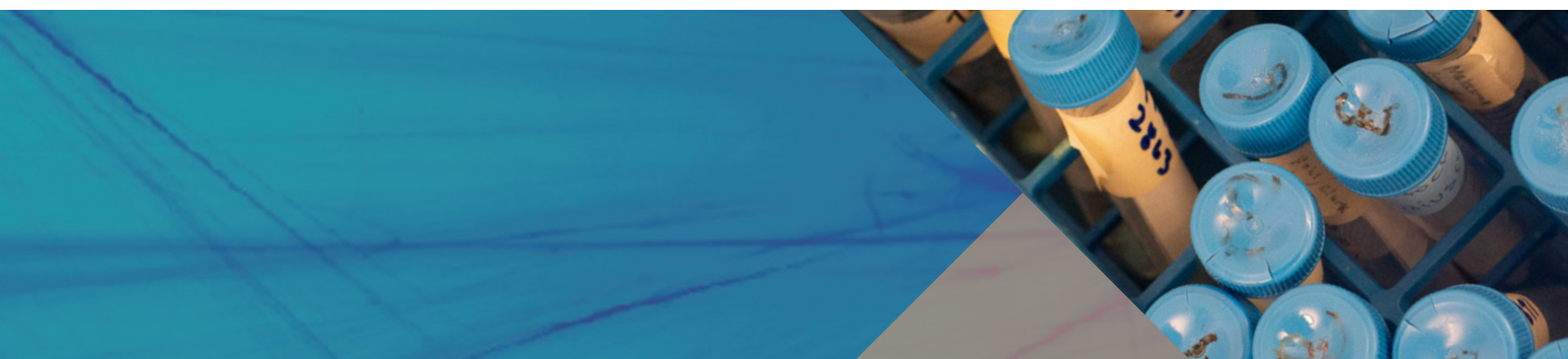




## Sample Bequest Language

In order to make a bequest, you should speak with your attorney. Your attorney can help you include a bequest to ARCS Seattle in your estate plan. We have provided some basic bequest language to assist you and your attorney.

1. Specific Bequest: I hereby give, devise and bequeath \_\_\_\_\_ and No/100 dollars (\$DOLLARS) to ARCS Foundation (Achievement Rewards for College Scientists) Seattle Chapter, a nonprofit organization located at 4616 25th Ave NE Seattle, WA 98105, Federal Tax ID #91-1042292, for ARCS Foundation Seattle Chapter's general use and purpose.
2. Percentage Bequest: I hereby give, devise and bequeath \_\_\_\_ percent (\_\_\_%) of my total estate, determined as of the date of my death, to ARCS Foundation (Achievement Rewards for College Scientists) Seattle Chapter, a nonprofit organization located at 4616 25th Ave NE Seattle, WA 98105, Federal Tax ID #91-1042292, for ARCS Foundation Seattle Chapter's general use and purpose.
3. Residual Bequest: I hereby give, devise and bequeath to ARCS Foundation (Achievement Rewards for College Scientists) Seattle Chapter, a nonprofit organization located at 4616 25th Ave NE Seattle, WA 98105, Federal Tax ID #91-1042292, ALL OR A PERCENTAGE of the rest, residue and remainder of my estate to be used for ARCS Foundation Seattle Chapter's general use and purpose.
4. Contingent Bequest: If (primary beneficiary) does not survive me, then I hereby give, devise and bequeath to ARCS Foundation (Achievement Rewards for College Scientists) Seattle Chapter, a nonprofit organization located at 4616 25th Ave NE Seattle, WA 98105, Federal Tax ID #91-1042292,
